Over the past 75 years, the effort to uphold universal human rights and religious freedom has evolved into a delicate balancing act between lofty ideals and harsh realities. Since its adoption in 1948, the Universal Declaration of Human Rights has stood as a pivotal document, leaving a distinctive mark on global legal, political, and social landscapes. Guided by an orientation for equality and dignity, nations worldwide have gathered within the United Nations to protect and promote fundamental principles of human rights and contribute towards inclusion, non-discrimination, and the protection of all people's rights. However, reflecting on the Universal Declaration of Human Rights, we may recognize that our aspirations are still far from being realized. Emerging challenges and ever-changing landscapes encourage us to strengthen universal human rights and religious freedom for future generations.

The fourth edition of the conference will take place around Human Rights Day, in celebration of the 75th anniversary of the Universal Declaration of Human Rights. The main focus will be on analyzing the profound impact of the Universal Declaration of Human Rights in various areas, including the advancement of human dignity, fundamental freedoms, human security, civil and political rights, including the freedom of religion or belief, law, human development, health, humanitarian rights, economic, social, and cultural rights, social justice, equality, and non-discrimination, among other related subjects.

Nelu Burcea serves as the Liaison of the Seventh-day Adventist Church & International Religious Liberty Association to the United Nations. He was the Director of Hope Channel Media Center in Romania (2003-2009) and producer of the TV program “The Right to Hold an Opinion” with the purpose of promoting religious freedom and human rights. He has been involved in academic research since 2011 by organizing international scientific conferences. He was the founder and editor of the Journal for Freedom of Conscience. Dr. Burcea has a PhD in Economics specializing in Business Ethics and Human Dignity, a Master’s degree in Business Development, and a Theology degree. He has also completed postgraduate study in Media and Marketing and Diplomatic Protocol and Communication and a Postdoctoral fellow at Harvard University focusing on religious freedom.



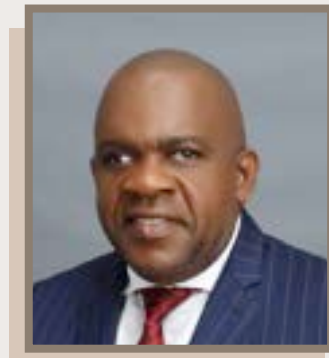
Bill Knott is associate director of the Public Affairs and Religious Liberty Department, and responsible for the Church’s interface with the U.S. Congress, the White House, and the international diplomatic corps. He brings to his new role a wealth of experience gleaned from more than 25 years of networking and connecting with thought leaders and faith communities in the metropolitan D.C. region, including six years during which he completed his doctoral degree at George Washington University in the heart of the District. Before joining the PARL team in January 2023, Knott was the editor and executive publisher of Adventist Review and Adventist World. Bill had served for 18 years as a pastor in congregations ranging in size from 6 to 1800, including as senior pastor of the Walla Walla University Church. He earned a B.A. in English and Religion from Atlantic Union College (1979); a M.Div. from the Seventh-day Adventist Theological Seminary (1983); and a Ph.D. in History from the George Washington University in Washington, D.C. (2006).



The Rev. Dr. Liberato C. Bautista is the President of CoNGO—The Conference of Non-Governmental Organizations in Consultative Relationship with the United Nations. Bautista teaches, writes and lectures extensively in a variety of fields, including international affairs; NGO and civil society dynamics; social and political ethics; theology and religion; ecumenism and religious liberty; human rights and human dignity; indigeneity and indigenous peoples; and peace, justice, and social transformation. He has taught politics and civil society at Kyung Hee University in Seoul, Korea, and dynamics of society and community organizing at Saint Andrews {Episcopal} Theological Seminary in the Philippines. Bautista studied political science, history, and international studies at the University of the Philippines in Manila which in 2000 awarded him the “Most Outstanding Alumnus in the Social Sciences.” His doctoral studies at Drew University in Madison, New Jersey focused on religion and social and political ethics.



Michael Wiener has been working at the Office of the United Nations High Commissioner for Human Rights since 2006. He co-organized the expert workshops that led to the adoption in 2012 of the Rabat Plan of Action on the prohibition of advocacy of national, racial or religious hatred that constitutes incitement to discrimination, hostility or violence. Since 2017 he has worked on the design and implementation of the Beirut Declaration and its 18 commitments on “Faith for Rights”. Since 2011 he also has been a Visiting Fellow of Kellogg College at the University of Oxford, and during summer 2022 he was Senior Fellow in Residence at the Graduate Institute of International and Development Studies in Geneva.



Floyd Morris completed his PhD at the UWI in 2017 and is the Director for the Centre for Disability Studies at UWI. Floyd Morris was called to national duties in 1998 when he became the first blind person to be appointed to the Senate. He distinguished himself and was promoted to a Minister of State in 2001. He was assigned to the Ministry of Labour and Social Security. Floyd Morris was re-appointed to the Parliament of Jamaica in 2012 where he served as a government Senator for four years. He was promoted to the President of the Jamaican Senate in 2013. He was also the host of a radio show, *Seeing From A Different Perspective*. He is the 2012 recipient of the Prime Minister’s Life-Time Award for Excellence in Disability Reform. In 2017, he was the RJR-Gleaner Communications Group Education Personality of the Year Awardee. In 2018 he was appointed as CARICOM’s Special Rapporteur on Disability. In 2020 he was selected as the UWI Vice Chancellor Awardee for Excellence in Public Service, and, on November 30, 2020, he was elected to serve a four year term on the United Nations Committee on the Convention on the Rights of Persons with Disabilities. In February 2021, he was selected as the Ansa Caribbean 2020 Laureate for Excellence in Civic and Public Service.



Prof. Amal Nagah Elbeshbishi is an Economist for the United Nations Economic Commission for Africa (UNECA) - Office for North Africa, Rabat- Morocco. She is also a tenured Professor of Economics at Faculty of Commerce- Mansoura University, Egypt [on sabbatical leave (national assignment) to work for ECA]. Prior to joining ECA in 2005, Ms. Elbeshbishi lectured at universities in Bahrain, Egypt and the United States of America. She has also worked with the United Nations Economic and Social Commission for Western Asia (UNESCWA) and the Egyptian Cabinet’s Information and Decision Support Center (IDSC). Ms. Elbeshbishi is the author/co-author of many research papers and books on several economic and social development issues. She holds a Master’s and a Ph.D. degree in Economics from Fordham University- New York, United States of America; and a Master’s degree in Economics from Mansoura University, Egypt.



Lucile Sabas is Assistant Dean of the College of Professions & Associate Professor of Finance & Economics at Andrews University, in Michigan. Lucile Sabas has been Associate Professor of Economics at the College of Professions since 2011 and Assistant Dean of the same College since 2021. Prior to this, she was professor of Economics and Financial Administration and research Director at the School of Administration at Montemorelos University in Mexico, university president of COSENDAI Adventist University in Cameroon, and principal of the Guadeloupe Adventist Conference High School in the French West Indies-Guadeloupe. She has served as the Head of the Education Department at the Guadeloupe Conference, and managed a medium-sized business with 45 employees. Sabas speaks French, English, Spanish and Creole, and has traveled and worked across the globe. Her work and numerous research, especially on questions of economic development have led her to participate in international conferences in more than 40 countries in Asia, Africa, Europe, North America, the Caribbean, South America and Australia.



Tina Ramirez serves as the Founder and President and brings to Hardwired 20 years of experience as an educator, foreign policy expert and authority on international human rights law and religious freedom. Previously, she served as a policy advisor for the U.S. Commission on International Religious Freedom, a foreign policy advisor for the U.S. Congress, where she founded the bi-partisan International Religious Freedom Caucus, and as former Director of Government Relations and International Programs at Becket Law. Tina has published extensively and is the author of *Iraq: Hope in the Midst of Darkness* (2017), a contributing author and editor of *Human Rights in the United States: A Dictionary and Documents* (2010 and 2017) and author/editor of *Human Rights: Great Events From History* (2019). Tina has worked in more than 30 countries, spoken before the United Nations and the African Union, and testified before the U.S. Congress. She holds a certificate from the International Institute for Human Rights in Strasbourg, France, a MA in Education from Vanguard University, and a MA in International Human Rights from the University of Essex, UK.



Dan G. Şerb holds a Master's degree in Social Sciences from the University of Cape Town, South Africa, and a Doctorate in Multicultural and Multi-ethnic Ministry through Andrews University, Michigan, USA. He is currently completing research for a PhD in Religious Studies through the University of South Africa, with special reference to the field of human rights and religious terrorism. Having previously worked as a lecturer, researcher, and minister of religion, Dan is currently serving as a church administrator. Dan G. Şerb is originally from Romania. After living and working for almost twenty years in South Africa, he currently resides with his family in Dublin, Ireland.



Teresa Flores Chiscul is a Lawyer graduated from the Catholic University Santo Toribio de Mogrovejo, Peru. Master's degree completed in Constitutional Law and Human Rights by the Universidad Nacional Mayor de San Marcos – Peru. Diploma in Religious Studies by the Catholic University of Chile. With experience in research and the study of religious freedom in the region. Intern at the Latin American Center for Human Rights – CLADH in Mendoza, Argentina. Junior researcher of the Gender and Family division of the Center for Advanced Social Research – CISAV in Querétaro, Mexico. Teresa Flores Chiscul gives lectures on issues related to hostilities against the right to religious freedom in different academic and political forums in Mexico, Peru and Colombia. She is currently working as director of the Observatory of Religious Freedom in Latin America – OLIRE, a research, training, and advocacy program whose mission is to promote religious freedom and highlight the restrictions on this right throughout the region.



Nicholas Miller is Professor of Church History at Andrews University and Director of the International Religious Liberty Institute. Nicholas Miller received his B.A. in theology from Pacific Union College and a J.D. from Columbia University Law School, where he was a Stone Scholar and an editor of the Columbia Law Review. He also has a Ph.D. in American Religious and Legal History from the University of Notre Dame, where he received the award for the best dissertation of the year for 2010 from the History Department. Dr. Miller has argued many church/state cases in state and federal courts, has appeared before the U.S. Supreme Court in the case of *Mitchell v. Helms*, and is the author of more than thirty scholarly and professional journal articles and book chapters dealing with issues of church, state, and society. His book on the development of religious freedom in America, *The Religious Roots of the First Amendment* was published by Oxford University Press in the summer of 2012, and he edited the Andrews University Press book on *Homosexuality, Marriage, and the Church* (2012).



Francesca Evangelisti holds a bachelor's in Anthropology curriculum science of religions from the "Alma Mater Studiorum–Università di Bologna," and a master's in "Religious Freedom, Freedom of Conscience, Rights and Geopolitics of Religions" at the "Facoltà Avventista di Teologia Villa Aurora" in Florence. She works for the Public Affairs and Religious Liberty Department of the Italian Union of Seventh-day Adventist Christian Churches in Rome. She is National Secretary of the International Association for the Defense of Religious Freedom (AIDLR) in Italy and Secretary of the Interreligious Table in Rome. She is also a member of the Globalization and Environment Commission (GLAM) of the Federation of Evangelical Churches in Italy, the scientific committee of the Center for the Study of Freedom of Religion Belief and Conscience (LIREC), the group Women of Faith in Dialogue of Religions for Peace Italy.



Abraham Bakari currently serves as Director of Public Affairs and Religious Liberty for the Seventh-day Adventist Church, West and Central Africa Region. He holds a Master's Degree in Communication. He has also completed several courses in Semiotics and Strategies - Semiotics of Advertising. He is currently a graduate student in Digital Humanities at Harvard University. He is a micro-influencer on social media with experience in communications over the past thirty years. He began advocating for religious freedom in the early 2000s. He has also made significant contributions to the promotion of religious freedom and regional integration within NGOs. He has often been consulted by the government of Cameroon on religious freedom issues. He played a major role in organizing the 3rd African Congress on Religious Freedom in 2013 in Yaoundé, Cameroon. This Congress mobilized over 1,500 participants from across Africa and was held under the patronage of the President of the Republic of Cameroon.



Titus Corlăţean, Ph.D., is a legal scholar, diplomat, lawmaker and educator. He holds a B.A. and a Ph.D. in Law from the University of Bucharest, and has conducted advanced studies in International Relations and Diplomacy at the International Institute for Public Administration in Paris, and at the National Defense College in Bucharest. He is the author of several books and numerous scientific papers in the fields of international law, human rights, and post-Soviet secessionism. He is Associate Professor at the Faculty of Law and Administration of "Dimitrie Cantemir" Christian University in Bucharest, Romania and also at the National University of Defense, where he teaches the International and European protection of Human Rights, International Law, Diplomatic and Consular Law. Dr. Corlăţean is a former visiting scholar at Harvard University/ the Center for the Study of World Religions. In terms of political activity, Titus Corlăţean is a member of Social Democratic Party. Since 2020, he has been Vice-President at national level. From 2004 until present, he has won a mandate of deputy and four consecutive mandates of senator. Dr. Corlăţean served as Romania's Minister of Justice, and as Romania's Minister of Foreign Affairs. Currently, Dr. Corlăţean serves as a Romanian Senator, Chairman of the Committee of Foreign Affairs of the Romanian Senate. In terms of foreign policy positions, he served as President of the Romanian National Delegation to the Parliamentary Assembly of the Council of Europe (2017-2018) and also Vice-President of the Parliamentary Assembly of the Council of Europe (PACE). Currently, Senator Corlăţean, member of the Romanian Parliamentary Delegation to the PACE, fulfills the position of Chairman of the Committee on the election of judges to the European Court of Human Rights.



Silvia Baldassarre holds a PhD in Law from the University of Padua; she is qualified to exercise the legal profession. Since 2018, she has been a research fellow at the University of Florence. She has participated in numerous national and international conferences and written scientific publications focusing on the issues of religious freedom and the rights of minorities of religion/belief. She is a member of the Scientific Committee of the journal "Coscienza e Libertà."



Marian Gh. Simion is a political scientist and a religious historian with a wide array of expertise ranging from social sciences and humanities to policymaking and management. He holds a PhD in international politics, policy, and law from Northeastern University in Boston and completed postdoctoral work at Harvard University in religion and diplomacy. Dr. Simion is a Cambridge University author, a coeditor of volume 9 of "Edinburgh Companions to Global Christianity," and author of several books and papers in his field. As a practitioner, Dr. Simion has a strong experience in international conflict transformation, human rights, and international public policy; working in countries. Currently, he splits his time on three continents working as a Field Education Supervisor and President of the Institute for Peace Studies in Eastern Christianity at Harvard Divinity School in Cambridge, MA, as visiting professor at Fitchburg State University, as a Senior Fellow at the Center for World Religions, Diplomacy and Conflict Resolution, at the Jimmy and Rosalynn Carter School for Peace and Conflict Resolution of George Mason University, as honorary Foreign Affairs Advisor at the Parliament of Romania in Bucharest, and as Associate Fellow at the University of Pretoria in South Africa.



Denise Burrill Simion, PhD, is an Assistant Professor at the School of Business at Fitchburg State University, USA, and Associate Researcher at the Corhis Research Center of Paul Valéry University Montpellier 3, in France, where she received her PhD. Dr. Burrill Simion is a co-founder and Chair of the Board of Trustees of IPSEC. She holds a Masters from Harvard University. Her research focuses on information systems management, business data analytics, business technology's impact on the global society, and leadership and communication in culturally diverse organizations. She has more than fifteen years of experience working in the financial and technology sectors. She is a coeditor of several volumes and of several peer-reviewed papers.



Julia M. Puaschunder is a post-doctoral researcher in the Interuniversity Consortium of New York at Columbia University. For the academic year 2023/24, she joins a European Law and Economics Programme at the University of Haifa, Hamburg University and Aix-Marseille University sponsored by the European Union. Previously, she was a faculty associate at Harvard University. Julia Puaschunder holds PhDs in Economics and Natural Sciences from the University of Vienna, Vienna University of Economics and Business as well as the Interuniversity Consortium of New York. Julia's research interests are Digitalization and Artificial Intelligence Ethics, Environmental Economics, Financial Social Responsibility and Intergenerational Equity. She authored 13 books on Resilient Finance, Responsible Investment, Behavioral Economics and Finance Leadership, Governance and Climate Justice, as well as Intergenerational Equity. She currently works on a monograph on Digital Inequality and Human Rights Online.



Thierry Valle has been an active advocate for human rights for more than two decades. He has extensive experience concerning freedom of religion and belief around the world. He organized numerous symposiums on religious freedom in France. Thierry has been a participant of the Organization for Security and Cooperation in Europe (OSCE) for the last ten years, speaking on issues relating to freedom of religion and restrictions on human rights as they relate to anti-terrorism laws in Europe. He has also written numerous reports for the OSCE. The Coordination of the Associations and the People for Freedom of Conscience is an European NGO with United Nations Consultative Status, created two decades ago and dedicated to protect the Right of Freedom of Religion and Belief. Developing their expertise for 20 years, defending religious minorities against discrimination, they produce reports on religious freedom issues and organize events, conferences, meetings to unite minority religions to counter discrimination in Europe and worldwide. Thierry also takes part in the European platform for Fundamental Rights, for which he has made numerous reports on violations of religious freedom in Europe.
